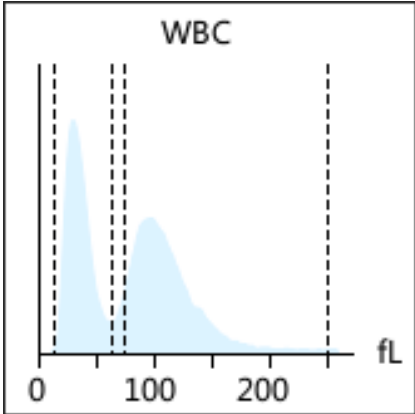




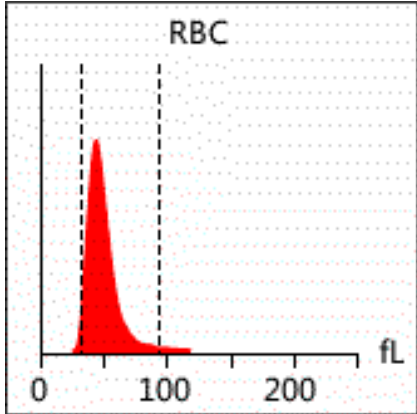

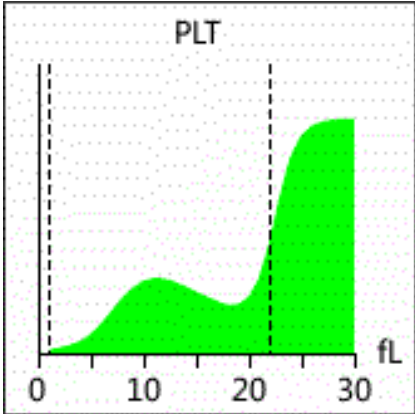
WBC Histogram



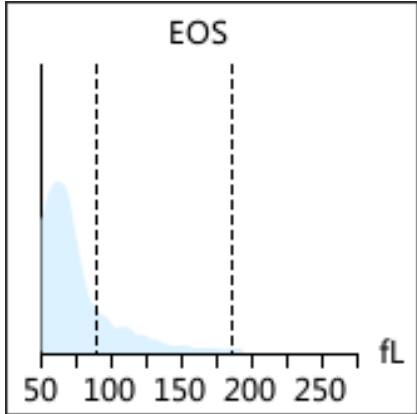
RBC Histogram
