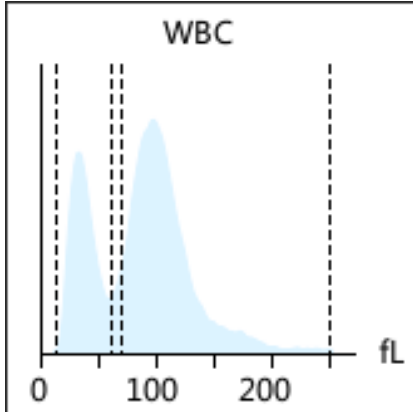

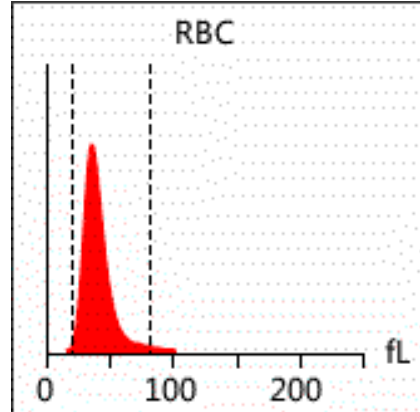

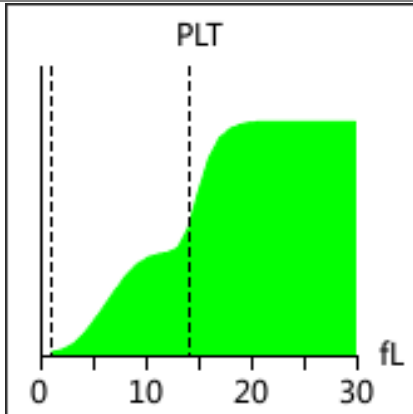
WBC Histogram



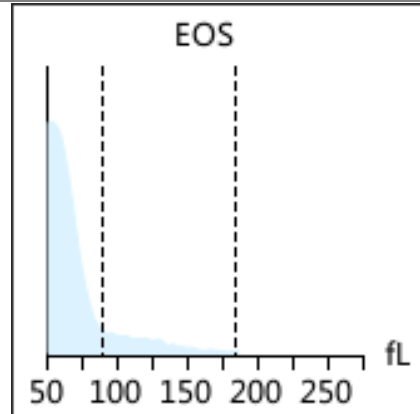
RBC Histogram
